**NOTICE OF WINDING UP AND APPOINTMENT OF JOINT
AND SEVERAL PROVISIONAL LIQUIDATORS**

Take notice that by order of the Supreme Court of Bermuda dated the 20th day of January 2020, it was ordered that:

1. The said Hsin Chong Group Holdings Limited (“the Company”) be wound up by this Court under the provisions of the Companies Act 1981 (Act);
2. Osman Mohammed Arab and Lai Wing Lun of RSM Corporate Advisory (Hong Kong) Limited, 29/F Lee Garden Two , 28 Yun Ping Road, Causeway Bay, Hong Kong and Mathew Conner Clingerman of KRyS & Associates (Bermuda) Ltd, Chancery Hall, First Floor, 52 Reid Street, Hamilton, HM 12 Bermuda be appointed as joint and several provisional liquidators of the Company;
3. The time for the holding of first the meetings of creditors and contributories under section 171 of the Act be extended to six months from the date of this Order;
4. The costs of the Petitioner be taxed and paid out of the assets of the Company as fees and expenses properly incurred in preserving and getting in the assets of the Company.
